Application Fee	\$600
Home Study Fee - <i>IF completed by MAA</i>	\$2,800- DE, NJ, PA, IL
OR- Review of Home Study if completed by other Agency	\$1000
Adoption Training & Education	\$100
DUE WITH PRE-PLACEMENT CONTRACT	
Agency Professional Services Fee- RETAINER	\$5,000
DUE AT PLACEMENT	
Remainder of Agency Professional Services Fee- <i>Includes administrative overhead, promotion and marketing, public outreach, 24/7 birthparent support and counseling, and all birthparent documentation fees.</i>	\$10,000
Legal Fees for Uncontested Termination of Parental Rights (DE Only)	\$2,600
Post-Placement Supervision- <i>IF by MAA- Minimum 4 reports required. Additional reports may be required by other states.</i>	\$450 per report
OR- Review and Submission of PP Reports by other Agency and Court report to be completed by MAA	\$1000
Interstate Compact Processing (if applicable)	\$1,200
Birth Parent/Family Expenses (if applicable)	Dependent upon Circumstances
OTHER POSSIBLE COSTS- DUE AT/ AFTER PLACEMENT	
Extraordinary Assistance for Birthparents/ Birth Family (if required)	\$150 per hour
Court Assistance (if required)	\$300
Temporary Custody of Child (if required)	\$65 per night + costs

Fees expected to be paid to Third-Party Providers during the adoption process:

Home Study (if not done by MAA)- \$2000- \$3000

Education Training Courses- \$0- \$250

Legal fees for Adoption Finalization- DE- \$2000

Travel to birthplace of child (if required)

Hotel and food if Interstate Compact requires stay in Birth parent state
